



## Do Unaffiliated Voters Help Republicans?

Apparently not. This graph shows unaffiliateds increasing their share of the vote in Republican primaries.



Meanwhile, this graph shows the Republican percentage of the vote decreased in general elections when unaffiliated voters increased their influence in Republican primaries.



There are many flavors of unaffiliated voters. But if you were a Democrat-leaning unaffiliated, seeing you didn't really have choices anyway in the Democrat primary, would you or would you not use your influence to vote in the Republican primary, for the most Democrat-aligned Republican?

Questions to ask:

- Why do we have a 117-year-old Republican woman registered in Englewood when Wikipedia lists the oldest person in the world as 116, in Spain?
- Why do we have 3 out of 184 centenarians (1.6%) who haven't yet figured out their gender, but only 1 of 393 16-year-olds (0.3%)?
- Why do we have 392 of 393 16-year-olds listed as active voters? (The FAQ page says ballots are sent to all active registered voters!)

The legislature is trying all kinds of "laws" that will clearly be declared unconstitutional (for instance the bills mandating support of abortion <a href="https://kristakafer.substack.com/p/three-colorado-abortion-bills-will">https://kristakafer.substack.com/p/three-colorado-abortion-bills-will</a>). But in the meantime it seems they hope to intimidate Coloradans into compliance. Coloradans are pushing back, and overwhelming public response has slowed or even stopped some of the overreach, even when every branch of government is "blue".

## Speak Up for Your County, City, Schools

Your biggest contribution is not your vote, but your involvement. You will have most effect if you start at your local level. Begin today, attending public meetings regularly – you will learn who the people are, whom to trust, and what motivates them. Don't get overwhelmed by the number of meetings – in many areas you could attend all the meetings up through the county level for an average time investment of just six hours a month! If you have nothing to say, listen – you'll almost certainly find something to say soon!

#### How to speak up

For most people it's a good idea to write out ahead of time what you want to say and practice it a time or two to make sure it fits in the time limit.

Most councils/boards give you 3 minutes to speak, which is arguably infringing on your right to free speech, but in practice if you can't say what you have to say in 3 minutes, people will tune you out. If enough people show up to speak they may cut the allowed time to 2 minutes, so be prepared with what you would cut out if necessary.

Many meetings hold public comment time early in the agenda, so you don't have to stay for the whole meeting, though if you do, then they know you're watching them! Most meetings are recorded; you could catch up on the rest of the meeting later by playing the video during your drivetime.

Some boards have been known to move the public comment time until after the most boring parts of the meeting; if so, hang in there and wait; the more they try to discourage you, the more you know you are making a difference!
